

MEMORANDUM BY THE MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the release of fifty (50) plots of land at Benghajsa, limits of Birżebbugia.

The fifty (50) plots of land in question had been declared to be required for a public purpose by the competent authority by means of a Declaration signed by His Excellency the Governor-General on the 19th February, 1969, and published by Government Notice No. 183 of the 20th February, 1969.

As the said fifty (50) plots of land are no longer so required by the competent authority, the attached Declaration is intended for their release.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

Whereas by declaration dated 19th February, 1969 published in the Government Gazette of the 20th February, 1969 under Notice No. 183, His Excellency the Governor-General had declared the undermentioned land to be required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and whereas the undermentioned land is no longer so required, I hereby declare for all intents and purposes of law, that the undermentioned land is no longer required by the competent authority for a public purpose in accordance with the provisions of the aforementioned Ordinance.

Description of the Land

The following land at Benghajsa limits of Birzebbugia:-

A plot of land of the area of 2 Sieghan and 1.6 Kejliet including the premises No. 12, Benghajsa Road and the rural structures thereon, bounded on the North-West and on the East by Benghajsa Road and on the South by property of Mr. Emanuel Farrugia; it is the property of Doctor Godfrey Randon LL.D. and others.
4. A plot of land of the area of 3 Tumoli, 3 Sieghan and 3.8 Kejliet, bounded on the East, and on the South-West and on the North-West by Benghajsa Road and on the North-East by property of Mr. Emanuel Farrugia; it is the property of Mrs. Fiorenza Said and others.
5. A plot of land of the area of 8 Tumoli, 2 Sieghan and 1.1 Kejliet including "Falcon House" in Benghajsa Road, bounded on the East by Benghajsa Road, on the North-East by Conception Street and on the South by property of Mr. John Cassar; it is the property of Mr. Paul Cachia.

6. A plot of land of the area of 4 Tumoli, 5 Sieghan and 5.9 Kejliet, bounded on the North by property of Mr. Paul Cachia, on the East by Benghajsa Road and on the South-West by property of Mr. Andrea Gauci; it is the property of St. Augustine Convent of Valletta as regards the directum dominium and of Mr. John Cassar as regards the temporary utile dominium.

7. A plot of land of the area of 6 Tumoli and 2.8 Kejliet, including premises No. 11, Benghajsa Road and the rural structures thereon, bounded on the East by Benghajsa Road, on the North-East by property of Mr. John Cassar and on the South by property of Mr. Felix Polidano; it is the property of Mr. Andrea Gauci.

8. A plot of land of the area of 11 Tumoli, 3 Sieghan and 1.2 Kejliet including half the width of an alley and premises No. 10, Conception Street, bounded on the North by property of the heirs of the late Gastano Polidano on the South by property of Mrs. Filomena Saydon and on the East partly by property of Mr. Joseph Aquilina, partly by property of Mr. Paul Cachia and partly by property of Mr. Bazzareno Aquilina; it is the property of St. Augustine Convent of Valletta as regards the directum dominium and of Mr. Elia Gauci as regards the temporary utile dominium.

9. A plot of land of the area of 4 Tumoli and 4 Kejliet, including half the width of an alley and a rural structure thereon, bounded on the North by property of Mr. Elia Gauci, on the South by property of Mr. Saviour Vella and others and on the East by property of Mr. John Polidano and others; it is the property of Mrs. Filomena Saydon.

10. A plot of land of the area of 3 Tumoli, 4 Sieghan and 6.8 Kejliet including half the width of an alley and premises No. 11, Conception Street, bounded on the North by property of Mrs. Filomena Saydon, on the South partly by property of Mr. Melitone Caruana and partly by property of Mr. Lawrence Barbara and on the West by property of Miss Olga Demarco; it is the property of Mr. Saviour Vella and others.

11. A plot of land of the area of 1 Tumolo and 6.9 Kejliet, bounded on the North by property of Mr. Paul Cachia, on the West by property of Mr. John Polidano and others and on the South by property of Mr. Joseph Polidano; it is the property of Mr. Paul Mallia and others.

12. A plot of land of the area of 3 Tumoli, 1 Siegh and 4.4 Kejliet, including the rural structure thereon, bounded on the North by property of Mr. Saviour Vella and others, on the South by property of Lady Genoveffa Boffa and on the West by property of Mr. Lawrence Barbara; it is the property of Mr. Melitone Caruana.

13. A plot of land of the area of 1 Tumolo bounded on the South by property of Mr. Joseph Polidano, on the West by property of Mr. Melitone Caruana and on the East by property of Mr. Joseph Polidano; it is the property of Mr. Anthony Mallia as regards the directum dominium and of Mr. Philip Farrugia as regards the utile dominium.

14. A plot of land of the area of 1 Tumolo, 3 Sieghan and 3.7 Kejbiet, bounded on the West by property of Mr. Philip Farrugia, on the East by property of Mr. Francis Griscti and on the South by property of Mr. Joseph Polidano; it is the property of Mr. Anthony Mallia as regards the directum dominium and of Mr. Joseph Polidano as regards the utile dominium.

15. A plot of land of the area of 1 Tumolo, bounded on the West and on the South by property of Mr. Joseph Polidano, and on the East by property of Mr. Philip Polidano; it is the property of Mr. Anthony Mallia as regards the directum dominium and of Mr. Francis Griscti as regards the utile dominium.

16. A plot of land of the area of 2 Tumoli, 3 Sieghan and 3.3 Kejliet, including the rural structure thereon, bounded on the West and on the South-West by property of Mr. Polidano, on the East by Benghajsa Road and on the North by property of Mr. Andrea Gauci; it is the property of Mr. Felix Polidano.

17. A plot of land of the area of 2 Tumoli 4 Sieghan and 2 Kejliet including premises No. 10, Benghajsa Road and the rural structure thereon, bounded on the East by Benghajsa Road, on the North-East by property of Mr. Felix Polidano and on the South partly by property of Mr. Anthony Mallia and partly by property of Mr. John Cassar; it is the property of Mr. Philip Polidano.

18. A plot of land of the area of 3 Tumoli, 4 Sieghan and 0.3 Kejliet, bounded on the East by property of Mr. Philip Polidano, on the South by property of Mr. Anthony Mallia and on the West partly by property of Mr. Melitone Caruana and partly by property of Lady Genoveffa Boffa; it is the property of Mr. Joseph Polidano.

19. A plot of land of the area of 8 Tumoli, 3 Sieghan and 6.2 Kejliet including the rural structure thereon, bounded on the East partly by property of Mr. Anthony Mallia and partly by property of the Sodality of Priests of St. Paul's Shipwreck Church of Valletta, on the North by property of Mr. Melitone Caruana and on the South-West by property of the Convent of Santa Scolastica of Vittoriosa; it is the property of Lady Genoveffa Boffa.

20. A plot of land of the area of 9 Tumoli, 4 Sieghan and 7.5 Kejliet including the rural structure thereon bounded on the West by property of Lady

Geneveffa Boffa, on the North partly by property of Mr. Joseph Polidano and partly by property of Mr. John Cassar and partly by property of Mr. Lewis Abdilla; it is the property of Mr. Anthony Mallia.

21. A plot of land of the area of 2 Tumoli, 1 Siegh and 8.2 Kejliet bounded on the East by Benghajsa Road, on the North by property of Mr. Philip Polidano and on the West by property of Mr. Anthony Mallia; it is the property St. Augustine Convent of Valletta as regards the directum dominium and of Mr. John Cassar as regards the utile dominium.

22. A plot of land of the area of 2 Tumoli, 2 Sieghan and 2.5 Kejliet, bounded on the East by Benghajsa Road, on the North partly by property of Mr. John Cassar and partly by property of Mr. Anthony Mallia, and on the South partly by property of the Zurrieq Parish Church and partly by property of the Legacy Andrea Abdilla administered by the Archbishop's Curia; it is the property of Saint Augustine Convent of Valletta as regards the directum dominium and of Mr. Lewis Abdilla as regards the utile dominium.

25. A plot of land of the area of 3 Tumoli, 2 Sieghan and 3 Kejliet, bounded on the East by Benghajsa Road, on the South by property of Mrs. Alberta Cachia and on the North by property of Mr. Lewis Abdilla; it is the property of the Parish Church of Zurrieq.

26. A plot of land of the area of 4 Tumoli, 2 Sieghan and 7.8 Kejliet, bounded on the East by Benghajsa Road, on the South by property of Mr. Anthony Griscti and on the North by property of the parish Church of Zurrieq; it is the property of Mrs. Alberta Cachia.

A plot of land of the area of 5 Tumoli, 3 Sieghan and 9.1 Kejliet including half the width of an alley and the rural structures thereon, bounded on the East by Benghajsa Road, on the North by property of Mrs. Alberta Cachia and on the South partly by property of the Convent of Santa Scolastica of Vittoriosa and partly by property of Mr. Joseph Polidano; it is the property of Mr. Anthony Griscti.

29. A plot of land of the area of 1 Tumolo, 1 Siegh and 3.4 Kejliet including half the width of an alley, bounded on the North by property of Mr. Anthony Griscti and on the South and on the West by property of the Convent of Santa Scolastica of Vittoriosa; it is the property of Mr. Calcedonio Bonnici as regards the directum dominium and of Mr. Joseph Polidano as regards the utile dominium.

30. A plot of land of the area of 1 Tumolo and 2.6 Kejliet including half the width of an alley bounded on the East by property of Mr. Alphonse Guaci, on the South by property of Doctor Herbert Ganado and on the West by property of the Convent of Santa Scolastica of Vittoriosa; it is the property of the Convent of Santa Scolastica of Vittoriosa.

40.
