Land Acquisition (Public furposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the release of forty-three (43) plots of land at Benghajsa, limits of Birżebbugia.

The forty-three (43) plots of land in question had been declared to be required for a public purpose by the competent authority by means of a Declaration signed by His Excellency the Governor-General on the 24th February, 1969, and published by Government Notice No. 200 of the 25th February, 1969.

DECLARATION BY THE GOVERNOR-GENERAL

Whereas by declaration dat d 24th February, 1969 published in the Government Gazette of the 25th February, 1969 under Motice No. 200, His Excellency the Governor-General had declared the undertentioned land to be required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Fublic Purposes) Ordinance (Chapter 136) and whereas the undermentioned land is no longer so required, I hereby declare for all intents and purposes of law, that the undermentioned land is no longer required by the competent authority for a public purpose in accordance with the provisions of the aforementioned Ordinance.

Description of the Land
