 - (6) In the case of a MARRIED WOMAN or WIDOW, the particulars of birth required are those of her HUSBAND or of her HUSBAND-as-was of the applicant herself.
 - (7) State whether a British-born Subject or a naturalised British Subject. IN THE CASE OF A NATURALIZED BRITISH SUBJECT, PARTICULARS OF BIRTH NEED NOT BE GIVEN.
 - (8) State whether proceeding; and Names of persons by whom accompanied (unless they hold separate passports, e.g., *not joined by husband, A. and children B. and C., and their Father, D. E., and a Governor, F. G., and a Maid Servant, H. K., and Aunt*).
 - (9) The Christian Name and Surname of each person must be given in full. In the case of persons proceeding to RESIDE, the ages of children should be stated; and the Religion of the applicant will be mentioned in the passport on production of a Religious Certificate or other satisfactory evidence.
 - (10) Where the applicant is unable to write, a note will be made by him or her in the presence of the person verifying the Declaration.
 - (11) Name and Qualification of person verifying the Declaration, viz. -
Not British Merchant, Banker, Member of Parliament, Physician, Surgeon, Barrister, or Solicitor (as the case may be), giving personal or business address.
