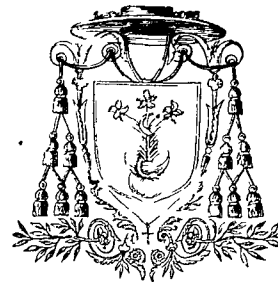

Resident British Merchant Bankers, Ministers of Religion, Physicians, Surgeons, Barristers at Law, or other persons of standing
Recommendations from Friends, Editors should have the printed stamp of the Bank
