(e) State whether proceeding, and names of persons by whom recommended (unless they hold separate passports) late wife A and children B and C will travel under D E and F G and H I J K and L M N O and P Q R (all British Subjects)
In the case of persons proceeding to RUSSIA the ages of children should be stated and the religion of the applicant will be mentioned in the passport on production of a Consular Certificate or other satisfactory evidence.
(f) Where the applicant is unable to write a mark should be made by him or her in the presence of the person verifying the Declaration
(g) Name and Qualification of person verifying the Declaration Resident British Merchant Banker, Minister of Religion, Physician, Surgeon, Barrister or Solicitor (as the case may be) giving professional or business address
Recommendations from Banking Firms should bear the printed stamp of the Bank.
