- (1) Insert name of Place and Date
(2) Christian Name and Surname of the applicant in full and present address
(3) In the case of a MARRIED WOMAN or WIDOW the particulars of birth required in that (1) & (2) must include HUSBAND and of the applicant herself
(4) State whether a British born Subject or a naturalized British Subject. IN THE CASE OF A NATURALIZED BRITISH SUBJECT, PARTICULARS OF BIRTH NEED NOT BE GIVEN
(5) State whether proceeding and names of persons whom accompanied, and if a female, state if accompanied by her husband or by a single man, and if so, state the name of the man.
In the case of persons proceeding to the Colonies (including the Straits Settlements and the Federated Malay States) the applicant will be required to state the persons to whom they are proceeding, and if so, state the names of the persons.
(6) Where the applicant is unable to write, a third party shall be called in to write for him or her in the presence of the person verifying the Declaration.
(7) Name and Qualifications of person verifying the Declaration in writing.
(8) Date, Place and Signature of the person verifying the Declaration, and if so, state the names of the persons.
(9) Recommendations from the Local Authorities should bear the printed stamp of the Local Authorities.
