The Name and Surname of the applicant in full as it appears in the passport of her husband or father.
If the applicant is a British-born Subject or a native of the British Subject in the full name of the father.
PARTICULARS OF BIRTH NEED NOT BE GIVEN.
If the applicant is a foreign-born Subject, the Name and Surname of the father and mother must be given in full.
The Christian Name and Surname of each person must be given in full.
The date of passage proceeding to Kenya, the ages of children should be stated, and the occupation of the applicant will be stated in the passport on production of a Diplomatic Certificate or other satisfactory evidence.
If the applicant is unable to write, a mark should be made by him or her in the presence of the person verifying the Declaration.
The Declaration should be verified by the Declaration viz:—
I, the Undersigned, Minister of Religion, Physician, Surgeon, Barrister or Solicitor (as the case may be), giving
my name and rank, and the printed name of the Bank.
