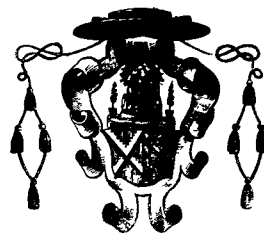

(f) The Christian Name and Surname of each person must be given in full
(g) In the case of persons proceeding to RUSSIA the ages of children should be stated and the religious denomination of the applicant will be mentioned in the passport on production of a Baptismal Certificate or other satisfactory evidence
(h) Where the applicant is unable to write a mark should be made by him or her in the presence of the person verifying the Declaration
(i) No fee and Certification of person verifying the Declaration via
Russo & Co. Bankers, 101, Strand, London, W.C.2. or any other Banker, Solicitor, or other person (as the case may be) giving professional or business address
Recommendations from a Bank should bear the printed stamp of the Bank.
