(e) Where the applicant is unable to write a mark should be made by him or her in the presence of the person verifying the Declaration

(f) Name and Qualification of person verifying the Declaration viz. —  
Resident in the U. K. or a Banker, Minister of Health, Physician, Surgeon, Barrister or Solicitor (as the case may be) giving professional or business address

Recommendations from a British Firm should bear the printed stamp of the Bank.
