(c) In the case of a MARRIED WOMAN OR WIDOW the particulars of birth require to be those of her HUSBAND OR LATE HUSBAND not of the applicant herself.
(d) State whether a British born Subject or a naturalized British Subject. IN THE CASE OF A NATURALIZED BRITISH SUBJECT PARTICULARS OF BIRTH NEED NOT BE GIVEN.
(e) State whether proceeding and Names of persons whom accompanied (unless they hold separate passports) and accompanied by his wife and children B and C with their T and D, and a Go or as F G and as D and as K and as L (all British Subjects).
(f) The Christian Name and Surname of each person must be given in full.
(g) In the case of persons proceeding to RESIDE the ages of children should be stated and the relation of the applicant will be mentioned in the passport on production of a Baptismal Certificate or other satisfactory evidence.
(h) Where the applicant is unable to write a mark should be made by him or her in the presence of the person verifying the Declaration.
(i) Name and Qualification of person verifying the Declaration viz. Resident Magistrate or Banker Minister of Education Physician, Surgeon Barrister or Solicitor (as the case may be) giving professional business address.
(j) Recommendations from Banking Firms should bear the printed stamp of the Bank.

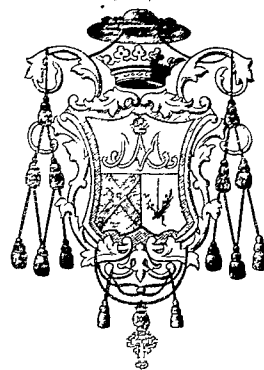
