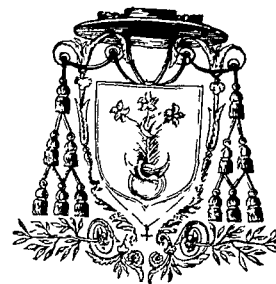

Resident in this Part of the United Kingdom Minister of Religion, Physician, Surgeon, Minister or Solicitor (as the case may be) giving professional or business address.
- (i) Recommendations from any one or more of the following should bear the printed stamp of the Bank.
