- (e) State whether proceeding and names of persons to whom accompanied (unless they hold separate passports) e.g., accompanied by his wife and children, or accompanied by Tutor, D. L., and Governess, T. G., and Maid Servant, if K. and Man Servant, L. V. (all British Subjects). In the case of persons proceeding to Russia the ages of children should be stated and the religion of the applicant will be mentioned in the passport on production of a Baptismal Certificate or other satisfactory evidence
- (f) Where the applicant is unable to write, or is ill or is made by him or her the presence of the person verifying the Declaration
- (g) Name and Qualification of person verifying the Declaration viz - Resident British Merchant, Banker, Minister of Religion, Physician, Surgeon, Barrister, or Solicitor (as the case may be) giving professional or business address. Recommendations from Banking Firms should bear the printed stamp of the Bank.
