(5) State whether proceeding, and Names of persons by whom accompanied (unless they hold separate certificates as approved by his wife, and children b and c with their Tutor, D, E, and a Governor, F, G, and the Minister of the Interior, H, K, and the Minister of the Interior, L, M (all British Subjects)  
The Christian Name and Surname (each person must be given in full  
In the case of persons proceeding, to Russia the ages of children should be stated and the religion of the applicant will be mentioned in the passport on production of a Baptismal Certificate or other satisfactory evidence  
(6) Where the applicant is unable to write a declaration should be made by him or her in the presence of the person verifying the Declaration  
(7) Name and Qualification of person verifying the Declaration viz —  
Assistant British Merchant, Banker, Minister of Religion, Physician, Surgeon or Solicitor (as the case may be) giving professional or business address  
Recommendations from Banking Firms should bear the printed stamp of the Bank.
