- (d) State whether a British born Subject or a naturalized British Subject IN THE CASE OF A NATURALIZED BRITISH SUBJECT, PARTICULARS OF BIRTH NEED NOT BE GIVEN
- (e) State whether proceeding, and Names of persons by whom accompanied (unless they hold separate passport) e.g. *accompanied by my wife A. and child A. B. and C., with their Father D. E., and a Governor F. G. and Ward-Sergeant H. K. and a Man-Servant L. M. (all Brit. Subjts.)*
- The Christian Name and Surname of each person must be given in full
- In the case of a child proceeding, to Russia, the age of children should be stated, and the religion of the applicant will be mentioned in the passport on production of a Baptismal Certificate or other satisfactory evidence
- (f) Where the applicant is unable to write, his name should be made known by the presence of the person verifying the Declaration
- (g) Name and Qualification of person verifying the Declaration — e.g. *Acting British Merchant, Banker, Master of the Ship, Justice, an, Surgeon, Barrister or Solicitor* (in the case may be), giving personal or business address
- Accompaniments from Banking Firms should bear the printed stamp of the Bank
