- (c) In the case of a MARRIED WOMAN or WIDOW, the particulars of birth required are those of her HUSBAND or LATE HUSBAND—not of the applicant herself
- (d) State whether a British born Subject or a naturalized British Subject IN THE CASE OF A NATURALIZED BRITISH SUBJECT, PARTICULARS OF BIRTH NEED NOT BE GIVEN
- (e) State whether procured, full names of persons by whom accompanied (unless they hold separate passports) *e.g. accompanied by his wife A. or by children B. and C. with their Tutor D. and a Governor E. G. and Visid Servant F. K. and Man Servant L. M. (all British Subjects)*
- The Christian Name and Surname of each person must be given in full
- For the case of a child, the age of the child must be stated, and the religion of the applicant will be mentioned in the passport on production of a Baptismal Certificate or other satisfactory evidence
- (f) Where the applicant is unable to write, a mark should be used by him or her in the presence of the person verifying the Declaration
- (g) Name and Qualification of a person verifying the Declaration viz
Resident British Merchant Banker, Minister of Religion, Physician, Surgeon, Barrister or Professor (as the case may be) giving full name and or law office address
- Recommendations from *Bankers, Firms* should be in the printed stamp of the 1-ink.

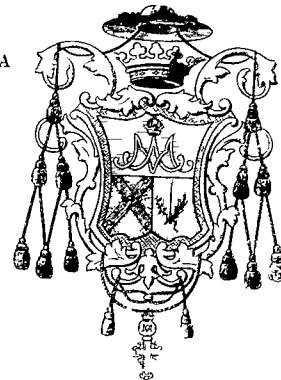
