Cabinet Meeting held at the Ambassadors' Palace, Valletta, on Thursday, 25th August, 1966, at 11 a.m.

Policies pursued by Malta Government representatives abroad.

H.C. The Governor-General was advised to sign Declaration for the acquisition of premises No. 59/61 Belvedere Street & No. 132 The Strand and No. 62, 63 Belvedere Street, Sgria, required by the Government for widening Belvedere Street.

Land 985/65.

H.C. The Governor-General was advised to sign Declaration for the acquisition of land at Santa Isidoro required for road widening.
