The Cabinet was
 informed of the history of Copyrights law

in Malta and was given the reasons for the necessity of a new law which took into account recent developments in the field of copyright in general and in the technical field in particular. The Amen Advocate General was to submit his further comments on the Bill, as shown in draft at Ref. 1B in file, at another meeting of the Cabinet.

Land 495/66. H.C. the Governor-General was advised to sign Declaration for the acquisition of land at Githin, required in connection with the construction of an electricity sub-station.

Land 460/62. H.C. the Governor-General was advised to sign Declaration for the acquisition of land at Pietà, required in connection with the extension of St. Luke's Hospital.

Land 1531/61. H.C. the Governor-General was advised to sign Declaration for the acquisition of premises No. 27 Saint Philip's Street, Vittoriosa, required for reconstruction purposes.
