LAND ACQUISITION (PUBLIC PURPOSES) ORDINANCE, CAP. 136

It is proposed to acquire the ten plots of land in Mosta described in the attached Declaration. The land is required in connection with the erection of the Phoenix Textile Factory and it is, therefore, obvious that the acquisition is being made for a public purpose.

Hon. Members are invited to recommend.

DECLARATION BY THE GOVERNOR

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following ten plots of land at Mosta.

1. A plot of land of the area of 304.1 square canes; bounded on the South-West by Government property, on the South-East by road Ta' Sghajtar, and on the North-East by the remaining portion of the Land of which such plot forms part; it is the property of Saint Dominic's Priory of Rabat.
2. A plot of land of the area of 460.8 square canes, bounded on the North-West by road Ta' Sghajtar, on the South by Old Notabile Road, and on the North-East and on the East by the remaining portion of the land of which such plot forms part; it is the property of Mrs. A. Borg Falzon.
3. A plot of land of the area of 396.2 square canes, bounded on the North by Old Notabile Road, on the West partly by property of Mr. Paolo Falzon and others and partly by property of Mr. Carmelo Deguara, and on the South and on the South-East by the New Notabile Road; it is the property of Rev. Paolo Borg.
4. A plot of land of the area of 175.1 square canes, bounded on the North by property of Mr. Paolo Falzon and others, on the East by property of Rev. Paolo Borg and on the South by the road leading to Mosta; it is the property of Mr. Carmelo Deguara.

5. A plot of land of the area of 138.2 square canes, bounded on the North by Old Notabile Road, on the West by road Ta' Sghajtar, on the South by property of Mr. Carmelo Deguara and on the East by property of Mr. Ignazio Fenech and others; it is the property of Mr. Paolo Falzon and others.

6. A plot of land of the area of 193.5 square canes, bounded on the North by Old Notabile Road, on the West and on the East by property of Mr. Paolo Falzon and others, and on the South by property of Mr. Carmelo Deguara; it is the property of Mr. Ignazio Fenech and others.

7. A plot of land of the area of 202.7 square canes, bounded on the North by Old Notabile Road, on the West by property of Mr. Ignazio Fenech and others and on the East by property of Mr. Carmelo Deguara; it is the property of Mr. Paolo Falzon and others.

8. A plot of land of the area of 5 Sieghan and 4 Kejliet, bounded on the South by property of the Noble Dr. Joseph Borg Olivier de Puget Paleologo LL.D., and on the North-East and on the West by the remaining portion of the Land of which such plot forms part; it is the property of the Noble G. Attard Montalto.

9. A plot of land of the area of 4 Tmien, 3 Sieghan and 8.6 Kejliet bounded on the South by property of the Noble Dr. Joseph Borg Olivier de Puget Paleologo LL.D., on the South-East by a land and on the North and on the West by the remaining portion of the land of which such plot forms part; it is the property of the Noble G. Attard Montalto.

10. A plot of land of the area of 1 Tomna, 1 Siegh and 8 Kejliet including a farmhouse, bounded on the North by property of the Noble G. Attard Montalto, on the East by Government property and on the South and on the West by the remaining portion of the land of which such plot forms part; it is the property of the Noble Dr. Joseph Borg Olivier de Puget Paleologo LL.D.
