

MEMORANDUM BY THE MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS.

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to twenty-four plots of land in the limits of Mdina.

As these plots of land are permanently required by the Government, it is proposed to acquire them by absolute purchase.

These twenty-four plots are required by the Government for the purpose of widening the road from Targa Gap to Rabat; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the 24 plots of land in question amounts to £865.10.0d.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

DESCRIPTION OF THE LAND

The following land in the limits of Mdina:-

1. A plot of land of the area of 0.86 kejlja, bounded on the West, on the South-West and on the South by a public road and on the North-East by the remaining portion of the land of which this plot forms part; it is the property of Dr. Joseph Vincenti M.D.

2. A plot of land of the area of 2.0 kejljet, bounded on the West and on the South-West by a public road and on the North-East by the remaining portion of the land of which this plot forms part; it is the property of Mr. Michael Galea.

3. A plot of land of the area of 5.6 kejljet, bounded on the West and on the South-West by a public road, on the South by property of Saura Hospital and on the North-East by the remaining portion of the land of which this plot forms part; it is the property of the heirs of the Noble Joseph Sant Cassia.

4. A plot of land of the area of 2 sieghan and 3.8 kejljet, bounded on the North by property of the heirs of the Noble Joseph Sant Cassia, on the South-West and on the South-East by a public road and on the North-East by the remaining portion of the land of which this plot forms part; it is the property of Saura Hospital.

5. A plot of land of the area of 2 sieghan and 1.1 kejliet, bounded on the West by a public road, on the South by property of Mr. Albert Xuereb and on the East by the remaining portion of the land of which this plot forms part; it is the property of the Cathedral Chapter of Mdina.

6. A plot of land of the area of 1 siegh and 9.2 kejliet, bounded on the North by property of the Cathedral Chapter of Mdina, on the West by a public road and on the East by the remaining portion of the land of which this plot forms part; it is the property of Mr. Albert Xuereb.

7. A plot of land of the area of 1 siegh and 0.4 kejliet, bounded on the West by a public road, on the South by property of Ta' Giesu Church of Valletta and on the East by the remaining portion of the land of which this plot forms part; it is the property of the heirs of Mr. Victor Xerri.

8. A plot of land of the area of 3 sieghen and 9.7 kejliet, bounded on the North by property of the heirs of Mr. Victor Xerri, on the West by a public road and on the East by the remaining portion of the land of which this plot forms part; it is the property of Ta' Giesu Church of Valletta.

9. A plot of land of the area of 2 sieghan and 5.23 kejliet, bounded on the South-East by a public road, on the South by property of Saura Hospital and on the North-West and on the West by the remaining portion of the land of which this plot forms part; it is the property of the Most Noble Marquis Nikola Mallia Tabone.

10. A plot of land of the area of 2 sieghan and 8 kejliet, bounded on the East by a public road, on the North by property of the Most Noble Marquis Nikola Mallia Tabone and on the West by the remaining portion of the land of which this plot forms part; it is the property of Saura Hospital.

11. A plot of land of the area of 1 siegh and 9.2 kejliet, bounded on the North by property of Saura Hospital, on the East by a public road and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr. Angelo Sammut and Mr. Joseph Mangion.

12. A plot of land of the area of 2 sieghan and 2.2 kejliet, bounded on the North by property of Mr. Angelo Sammut and of Mr. Joseph Mangion, on the East by a public road and on the West by the remaining portion of the land of which this plot forms part; it is the property of Saint Dominic's Church of Rabat, Malta.

13. A plot of land of the area of 2 sieghan and 6.4 kejliet, bounded on the North by property of Saint Dominic's Church of Rabat, Malta, on the East by a public road and on the West by the remaining portion of the land of which this plot forms part; it is the property of unknown owners.

14. A plot of land of the area of 1.0 kejliet, bounded on the East by a public road, on the South-East and on the South-West by property of Mr. Salvatore Galea and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr. Salvatore Galea and others.

15. A plot of land of the area of 3.6 kejliet, bounded on the East by a public road, on the South by property of Mrs. Carmela Agius and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr. Salvatore Galea.

16. A plot of land of the area of 3.5 kejllet, bounded on the East by a public road, on the North by property of Mr. Salvatore Galea and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mrs. Carmela Agius.

17. A plot of land of the area of 3.0 kejllet, bounded on the East by a public road, on the North by property of Mrs. Carmela Agius and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr. Victor Calleja and others.

18. A plot of land of the area of 1 siegh and 4.0 kejllet, bounded on the North by property of Mr. Victor Calleja and others, on the East by a public road and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr. John Galea.

19. A plot of land of the area of 1 siegh and 3.5 kejllet, bounded on the North by property of Mr. John Galea, on the East by a public road and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr. Victor Calleja and others.

20. A plot of land of the area of 1. siegh, bounded on the North by property of Mr. Victor Calleja on the East and on the South-East by a public road and on the West by the remaining portion of the land of which this plot forms part; it is the property of Dr. Alexander DePiro Gourgion LL.D.

21. A plot of land of the area of 3.5 kejllet, bounded on the West by a public road, on the South by property of Mr. Joseph Deguara and on the East by the remaining portion of the land of which this plot forms part; it is the property of Mr. Giuseppe Maria Gauci.

22. A plot of land of the area of 4.0 kejllet, bounded on the North by property of Mr. Giuseppe Maria Gauci, on the West by a public road and on the East by the remaining portion of the land of which this plot forms part; it is the property of Mr. Giuseppe Deguara.

23. A plot of land of the area of 3 sieghan and 2.6 kejllet, bounded on the North by property of Mr. Giuseppe Deguara, on the West and on the South-West by a public road and on the East and on the North-East by the remaining portion of the land of which this plot forms part; it is the property of the heirs of Mr. Victor Kerri.

24. A plot of land of the area of 1 siegh and 6.8 kejllet, bounded on the North-East and on the South-East by a public road and on the West by the remaining portion of the land of which this plot forms part; it is the property of the heirs of Mrs. Mary Schembri.

The above mentioned land is shown on a plan marked L.D. 286/66 which may be seen on demand at the Land Office, 29, South Street, Valletta.
