As Honourable Ministers are aware taximeters have been fitted to all taxis plying for hire in Malta. Indeed the only one not so fitted had been suspended from operating as from 1962.

Unfortunately taxi-owners in Gozo had not been as recipient to the introduction of taxi-meters as their counterpart in Malta.

As matters stand the omission to operate the taxi-meter in a taxi car on hire is not illegal.

This state of affairs has brought in its wake some very bad publicity in the local and United Kingdom press. Tourists have been lodging protests against excessive fares charged by unscrupulous taxi-drivers.

It has been thought to be appropriate to amend the Police Code with a view to making it compulsory on taxi-drivers to use the taxi-meters and to charge the fares shown thereon with such additions in accordance with the fares provided for in tariff D of the First Schedule to the Police Code.

Honourable Ministers had already agreed to the principle contained in the draft bill (Memo No. 166 of the 24th June 1963 refers). The Bill was, however, caught up in the Independence doldrums and owing to the extra-pressure of work it was not proceeded with.

The Bill has now been re-drafted and Honourable Ministers are invited to recommend.

Short title.
