MEMORANDUM BY THE MINISTER OF JUSTICE  
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of two plots of land at Stables, Limits of Rabat.

since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above plots of land are required by the Government for the purpose of road widening; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above plots of land amounts to £106. 2. Od.

Honourable Ministers are invited to recommend.


Description of the land

2. A plot of land of the area of 3 Sieghan and 6.3 Kejliet, bounded on the North and North-East by property of Mr. Salvatore Gauci, on the South and South-West by a public road, and on the East by property of the Noble Doctor Francis Apap Bologna, M.D.
